PARLEY'S CANYON

PARLEY'S CANYON IS ONE OF THE ICONIC GATEWAYS IN THE WASATCH FRONT. IT IS ALREADY
CHALLENGED WITH DUST FROM AN EXISTING MINE, AND IS NOW UNDER THREAT FROM AN
ADDITIONAL PROPOSED MINE. THE 139,000 PEOPLE LIVING WITHIN A 3-MILE RADIUS WOULD BE
PUT AT RISK FROM ADDING THE POLLUTION SOURCE TO THE CANYON. UPHE IS WORKING WITH
CIVIC GROUPS AND CITY GOVERMENTS TO EDUCATE PEOPLE ABOUT THE HEALTH DANGERS FROM
FUGITIVE DUST AND TO ADVOCATE FOR THE STRICTEST STANDARDS ARE INPLACE AND FOR
ENVIROMENTAL LAWS TO BE ENFORCED.
